FOURTH QUARTER 2022 APPENDIX 4C AND TRADING UPDATE

Boart Longyear Group Ltd (ASX:BLY) (the Company or Boart Longyear), the world's leading provider of drilling services, an expert in providing valuable orebody knowledge, and a pioneer in innovative drilling equipment and performance tooling, announces the filing of its fourth quarter Appendix 4C and trading update for the period ended 31 December 2022. The information provided is in accordance with Listing Rule 4.7C. The Company will release full year results on 24 February 2023. All results are referenced in US dollars.

During the fourth quarter 2022, net cash flows from operating activities were \$40.4 million, including payments for operating activities totalling \$221.3 million, all of which were in the normal course of business.

Net cash flows used in investing activities during the quarter were \$12.8 million and net cash flows used in financing activities were \$19.0 million.

During the period, payments to related parties were \$0.5 million for payments to Executive and Non-Executive Directors.
