- the final number of securities issued under the members' scheme of arrangement (Scheme) to effect the re-domiciliation of Boart Longyear Limited ACN 123 052 728 (BLY Australia) from Australia to Canada; and
- the capital structure of the Company.

Unless the context requires otherwise, capitalised terms not defined have the meaning given in the information memorandum dated 23 September 2021 and included in the Company's announcement on 29 September 2021.

### 1. Capital Structure

At the date of this announcement and immediately following implementation of the Scheme, the Company has 295,916,747 shares on issue held by CHESS Depositary Nominees Pty Limited ACN 071 346 506, equivalent to 295,916,747 CHESS Depositary Interests (**CDIs**) quoted on ASX.

In addition, in connection with the Scheme, the Company has agreed to assume the obligations of BLY Australia with respect to the following securities issued by BLY Australia:

- 103,790 quoted Ordinary Warrants;
- 14,141 unquoted Class A Warrants;
- 7,254 unquoted Class B Warrants;
- 32,782,148 unquoted New Warrants; and
- 2,166 unquoted BLY Options.
