BOART LONGYEAR RECAPITALISATION UPDATE – CREDITORS' SCHEMES BECOME EFFECTIVE

Boart Longyear Limited (ASX:BLY) (Boart Longyear or the Company) advises that the orders of the Supreme Court of New South Wales approving the Secured Creditors' Scheme and the Unsecured Creditors' Scheme have today been lodged with the Australian Securities and Investments Commission. As a result, the Secured Creditors' Scheme and the Unsecured Creditors' Scheme have each now become legally effective.

The Restructuring Implementation Deed which was annexed to the Creditors' Schemes has now been executed by the Company and all other parties to that document and has become effective.

Proposed implementation dates for Recapitalisation and Re-domiciliation Scheme

The Company announces that, as notified by the Scheme Administrators to the Company:

- the proposed implementation date on which the steps to implement the Creditors' Schemes and other Recapitalisation transactions will be commenced, is Thursday, 23 September 2021; and
- subject to the Re-domiciliation Scheme being approved by the Court, the proposed implementation date for the Re-domiciliation Scheme is Tuesday, 5 October 2021.

It is expected that the implementation steps that are required to be undertaken under the Restructuring Implementation Deed for implementation of the Creditors' Schemes and other Recapitalisation transactions will be completed over 2 days. In particular, the Company expects that the issue of Shares by the Company under the Share Purchase Plan and the buy-back of Shares by the Company under the Selective Buy-Back will now occur on Friday, 24 September 2021.

No creditors elected to participate in the Creditor Share Purchase Option and consequently no shares will be issued by the Company under the Creditor Share Purchase Option.
